## **Mentoring Seminar**

A Mentoring Seminar was held at Brimsdown FC on Thursday 27 April attended by a group of nine Society members, including Steve Conway who will act as the Society Mentoring Officer. Middlesex FA Learning Instructor, Andy Taylor, presented the Seminar, which covered the role of a Mentor and what he/she would be expected to do to help new referees.

Andy explained that being a Mentor would not necessarily take up an inordinate amount of time and help would be given where needed. Mentors would be asked to discuss relevant issues with their Mentee by telephone or email and offer advice as required. It is important that contact is maintained between the Mentor and Mentee to allow a partnership to develop – the essence is to encourage the Mentee to referee and to join the Society. Where possible, Mentors should watch their Mentees referee giving support, encouragement and advice.



## **April's Guest Speaker – Janie Frampton**

Gary Cobden introduced our special guest, Janie Frampton, who he said was a qualified UEFA 'B' Coach, FA Licensed Referee Instructor, FA Generic Tutor Trainer, Tutor Mentor for Child Protection and FA Regional Referee Manager for the South of England – and a qualified referee for 16 years!

Janie invited discussion on many aspects of refereeing, starting with 'Areas of the Game', a montage of video clips showing officials in action at the last World Cup. Discussion followed and included application of the Laws, judgement on penal offences and players questioning decisions. We were asked, "Do we apply Law correctly?" And were reminded that when determining offside, 'playing or touching the ball' is not the same as 'playing at', which doesn't count! We should manage our game, and our tolerance level should be consistent throughout. We were advised to send off anyone who showed dissent directly at us, and to recognise and correctly handle misconduct – always following the spirit of the Law.

On 'Movement and Positioning' we were asked to consider and discuss a number of points, including the importance of being in a good position for restarts, having a clear view of incidents, taking a side-on view, and our proximity to play. We were advised to anticipate in what area on the FOP we might be needed next. We should also be prepared for quick breaks and counter attacks and, as Assistants; we should never be 'flatfooted'. To be 'wide and deep' is not always necessary – we should have the ability to move into position quickly to diffuse a situation. However, being too close can mean peripheral vision is impaired. We discussed how poor positioning could cause us to miss incidents. Also, do we read the pattern of play sufficiently well and is our fitness level sufficient for the games we referee.

Good and poor examples of 'Advantage' were widely discussed. We were asked to consider if we applied advantage too liberally. It was generally agreed that at the 'grass roots' players are more likely to prefer a free kick to 'advantage'. Communicating to players that advantage is being played is important and we should also deal with any offending players, "I'm coming back for you, number 5"!

On 'Signals and Communication', we were advised to give decisions clearly and to make sure they were fully understood. We were also asked not to ignore players and if necessary to explain decisions, using good body language – and we shouldn't talk too much! We were also advised not to be disrespectful to players but that we should still 'boss' the game, making sure we stop play effectively when required. If after having to speak to a couple of players early in the game, consider cautioning the third one who transgresses, to get the message across – this becomes more important the higher up the ladder we go. "Start strong", was the message from our guest.

On 'Controlling the Game' we were urged to inspire respect, be confident and quick-thinking and have courage at major incidents. We should also use our management skills in dealing with misconduct. "Keep close control of the game – use it to keep it!" was the message.

Stan Rosenthal of the NMRS Training School gave a vote of thanks to Janie, for an excellent presentation, which he said had combined 'in-service training' with 'learning through interaction'. Stan then presented our special guest with a copy of 'The History of The North Middlesex Referees' Society' as a memento of her visit.

#### **CRB & Child Protection**

Thank you for your letter dated the 22<sup>nd</sup> February 2006 concerning the above.

When a referee undertakes the child protection workshop, or having completed the best practice guide, a certificate is sent to the individual, usually within 6 to 10 weeks. This certificate contains a unique number and confirms participation. With regard to CRB checks, again the forms are processed via the CRB unit and it takes approximately 8 to 10 weeks for the certificate to be issued.

Unfortunately there has been a slight administrative problem concerning Middlesex, however this has been rectified and all CRB checks are processed expediently. A recent decision made by The FA Referees Committee will allow all referees to register for season 2006-07. The County Football Associations will soon be receiving guidance from The FA in respect of registrations and those referees who have not undertaken the check or child protection training.





Matters Arising: There were no matters arising.

**Secretary's Report:** The Secretary thanked members of Society for there support and help for the smooth running of the Society business over the year. Again we had poor attendances at Society meetings along with very poor support for the social functions. The Secretary informed the meeting that he would be stepping down at the end of the season after four years and felt it was time for a younger member to come forward with new ideas. A vote of thanks was then proposed to the Chairman, and the formal part of the meeting closed at 9.00pm.

## **Treasurers Report Season 2005/2006**

Printed elsewhere in this month's magazine are the accounts for the year ended 31 March 2006. I am pleased to report that the Society returned a surplus of Income over Expenditure of £625.32. For the fifth consecutive season the Society maintained early payment Subscriptions at a level of £10, and there has been no increase again for season 2006/2007. Membership for season 2005/2006 was down by 73 on the previous season, and overall income was down by just under £260. Expenditure was also down - by £630. The main reasons for reductions in Income - Subscriptions; and no Special Raffle (held last season to partially offset the loss on Social Events – which this year returned a surplus from one event). Expenditure reductions arose from - Magazine (less copies, and more distributed by e-mail), Meeting Hall (change of venue); Conference (format change); and the Social Events which this year returned a surplus. As you will see from the accounts, we have taken a one-off charge to profits in respect of a Provision for Corporation Tax. In his recent Budget, the Chancellor announced that he was to tax INCORPORATED Societies and Organisations at a rate of 19%. We therefore thought it prudent to take a similar charge in case the Chancellor decides to take similar action against Unincorporated Societies and Organisations like ourselves. The Chancellor has a right to claim back several years, so we have calculated this figure based on Gross Interest received over the last seven years. In future years, the figure taken this year will be adjusted to represent a 19% charge on the previous seven years interest, so there may be either a small chare, or even a reduction in the current level of provision. Should anybody have any questions on the accounts, I will be pleased to answer them at the Annual General Meeting.

You are reminded that you will not be covered by the Referees Association Insurance after 30 June 2006 unless your fees have been paid to the Society.
